

# Core Return Policy



The TRC Core Return Policy includes:

- Prepaid Freight on all qualifying core returns
- All necessary paperwork included with every unit
- Pre-filled out Bill of Lading to streamline returns

## Core Return Policy

- Cores must be returned within **6 months** of the original invoice date to be eligible for credit.
- Cores must be the same model as the unit purchased; **“Like for Like”**.
- Cores must be **completely drained** of all oil.
- Cores must be **fully assembled** and have **no missing parts**.




Figure 1b - Core Return Tag

- Cores must have a **core return tag attached to the core** to receive full credit (figure 1a & 1b).
- Must have a **minimum of 2 cores per pallet** to be eligible for prepaid core return (figure 1a).
  - A \$75 charge will be issued on single core pallets returned.
- If multiple pallets returned under one BOL include copy of BOL with **each** pallet in a document bag (figure 1a).
- **Contact the Designated Carrier** provided on the Bill of Lading (figure 2) to **schedule a pick up**. Failure to use the designated carrier will result in a charge back for the difference in freight cost.

Adhering to this procedure will ensure your core returns and credits are processed within 72 hours of core receipt. Failure to abide by this procedure will result in credit ineligibility or delays.

### Disclaimer

Any Transmission, Differential or Steering gear that is burnt up, has bulging cases, units that have been exposed to fire or units that have severe rust as a result of prolonged weather exposure will not be acceptable for any core credit.

**Core Return Tag Must Be Attached to Core**

- No need to fill in your information
- All information is provided by the unit serial number
- Tags are waterproof and tear resistant
- All tags are provided with a zip tie to ensure the tag remains attached to the core
- **Perforated portion not to be removed**
